**Collaborative Agreement between
 Martin County, a political subdivision of the State of Florida, and
 Florida Department of Juvenile Justice**

This agreement details the cooperative/collaborative efforts between the two parties to effectively administer quality after school/out of school programs for the residents of Martin County, ages 5-18, from July 1, 2015 through June 30, 2016. The After School/Out of School program locations are:

- G.A.A.P. (Golden Gate Alternative After-School Program). Located at the Cassidy Center in Lamar Howard Park, 2895 SE Fairmont St. Stuart, FL 34997.
- J.A.S.E. (Jensen after School Experience). Located at Vince Bocchino Community Center, 2369 NE Dixie Hwy, Jensen Beach, FL 34957.
- X-treme Teen (Programs are scheduled county-wide in all of Martin County)
- B.L.A.S.T. (Banner Lake after School Time). Located at the Banner Lake Civic Center, 12212 SE Lantana, Hobe Sound, FL 33453.
- R.E.A.C.H. (Residents Empowering All Children's Hope) Located at Costella Williams Learning Center, 4450 SE Field St., Stuart, FL 34997.
- P.L.A.C.E. (Parks, Leisure, Arts, Culture and Education). Located at Big Mound Park, 15205 SW Indianmound Dr. Indiantown, FL 34956.

Martin County, through its Parks and Recreation Department (MCP&R) agrees to the following:

1. Provide all collaborative partners with updated information about all after school and out of school programs services being offered in a timely manner.
2. Refer program participants (children families) to other collaborative partners for specialized services not provided by MCP&R.
3. Work with collaborative partners to increase their participants' clients' involvement in recreation, sports, fitness arts and cultural programs and activities

The Department of Juvenile Justice agrees to the following:

To continue to review all after school/out of school participant registrations in MCP&R programs, on an annual basis, and provide information on juvenile infractions.

This agreement and party's participation in this Agreement may be terminated by either party by providing written notice to the other party, in writing.
